Market Intelligence

The energy sector is at a pivotal moment with net zero goals looming closer and the climate emergency becoming more imminent. Carbon capture technology has been heralded as a transition technology able to decarbonise not only our current energy mix but across all emitting industries. Europe is becoming home to several large-scale carbon capture developments looking to reduce emissions across industrial clusters and paving the way for regional infrastructure of significant importance. Alongside capturing emissions, Europe is witnessing sweeping deployment of hydrogen, from natural gas in conjunction with carbon capture and from renewable sources. Hydrogen has been labelled the fuel of the future, able to be adopted across several sectors – industrial, heating, transport, storage, to name a few. Over 130 hydrogen projects have been announced since 2020 in Europe echoing the potential the region has to be leaders in the sector.

While we continue to see growth in the clean tech sector, interest in upstream E&P continues especially in UK and Norway. In 2023, it is anticipated that at least nine upstream projects in the region will reach their final investment decision. O&G companies have been given a clear mandate to secure supply in the short term while transitioning to cleaner energy in the long term. Energy security is the utmost priority in Europe, and fossil fuels are integral to the solution. The advancement of projects, investments decision on developments made, pushed by the government, as well as the intensification of efforts to decarbonise the sector are clear indicators of growth and opportunity for the sector.

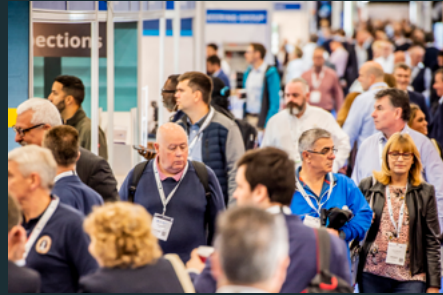
